











# CALL FOR PARTICIPANTS FOR AN INTERNATIONAL WORKING GROUP ON YOUTH POLICY AND THE ROLE OF YOUTH WORK IN PREVENTING VIOLENT EXTREMISM OF YOUTH 25/10 - 28/10/2017, BRUSSELS, BELGIUM

The main goal of this project is to set up a series of meetings between youth workers and youth policy stakeholders to present and discuss the needs of youth workers in the prevention of processes of youth radicalisation leading to violent extremism. During a full four day meeting in Brussels, youth workers will have the chance to re-view work dedicated to this topic, exchange ideas and practices, and formulate key messages for the use of youth policy actors at European level. In the follow up actions, participants in the projects will be able to report on the conclusions deriving from the meetings and work sessions to their national and regional governments.

# Profile of the participants:

- Youth workers or youth leaders (employees or volunteers) active with young people in the framework of open youth work associations, groups and projects whether they are member of the European Confederation of Youth Clubs (ECYC) or not
- Educators and project leaders, in a broad sense of the term, i.e. carrying out open youth work educational activities with young people;
- Motivated to work and to develop collaborative European multiparty projects that develop the Human Rights perspective;
- Interested in developing their competence in the themes of youth work preventing violent radicalisation of youth;
- Resident in one of the 47 Concil of Europe countries;
- Aged 18 or older at the time of travel;
- Able to work in English.

Before filling in your application, please have a look at the "Practical information" below to make sure that you agree and are comfortable with the practical terms and conditions for the training course.

### **Practical information**

- **Arrival** in Brussels during the day 24/10/2017, no later than 19.00
- **Departure** on 29/10/2017 after breakfast
- **Accommodation and meals** will be provided and paid for. Participants may need to share rooms.
- Each participant is required to pay an **enrolment fee** of 75 Euros. This amount will be deducted from the amount to be reimbursed for travel expenses.
- Travel costs will be reimbursed in full after deducting the participation fee. Participants MUST follow the **travel rules** outlined by the Council of Europe regarding type of travel, tickets and so on. Failure to follow these guidelines will lead to the travel reimbursement NOT being paid to the participant(s). Travel expenses and visa fees are reimbursed (on presentation of the relevant receipts) according to the rules of the Council of Europe. Only the participants who attend the entire meeting can be reimbursed. The payment will be made by bank transfer after the end of the meeting. Participants are asked to use the cheapest transportation possible. *Please do not book your flights until your participation has been confirmed!!*
- Participants requiring a visa should be in contact with the ECYC secretariat as soon as possible. The cost of the visa will be reimbursed upon presentation of a receipt. Agency fee or visa service fee will not be reimbursed. If the participant has to travel to get the visa the cost of the travel is not automatically reimbursed.
- Each organisation sending participants is responsible for arranging suitable insurance coverage (travel + physical / medical) of their own delegates.
