# Project Information

Empowerment defined as a process involving social, political and legal changes to enable people who are marginalised and disadvantaged in the society to participate and shape their life in the context of development and poverty reduction. Most approaches in empowerment discourse focuses on capacity building of an individual and at the same time deconstruction of norms, structures and the networks shaped in social boundaries to increase social mobility of individuals in social stratification. The NGOs, international development agencies considers the empowerment generally in 4 different pillars as such : Social, Economical, Political and Cultural Empowerment. Most distinctive feature of legal empowerment concept defined by OS Justice Initiative from universal legal support mechanisms is to act collectively as we indicated before. In other words, it is the approach of “We will solve this together” rather than “We will solve this problem for you” approach. In a sense case of working with disadvantaged societies and increasing the capacities of the individuals to solve the problems of the others collectively creates the basis of para legal support mechanism.

Mainly increasing the youth workers knowledge on legal manners to help the marginalized and excluded young people will play a huge role on their empowerment and their involvement to the social life. Therefore, we planned to implement this project to increase the capacities of youth workers as well as the young people in long run to teach them about human rights violations and tackle with this violations through out the legal empowerment in European Context by qualifying youth workers as paralegals.

The objectives of the project are ;

- To create a common understanding about human rights violations
- To raise an awareness about social stratification and social mobility
- To inform youth workers about New Tactics on Human Rights ( <http://newtactics.org> )
- To raise an awareness and create a knowledge about fundamental rights
- To qualify youth workers on human rights' issues to act through out legal channels to address the legal needs of the disadvantaged societies ( marginalized youth, refugees, socially excluded groups, minorities )

## Participants Profile & Language

- 18+ years old
- Have been delivering educational activities or counselling for the young people
- Has a prior exposure to non-formal education activities
- Willing to work intercultural setting
- Has attentiveness to learn empowerment programs, legal issues and social rights
- Less knowledge on legal issues
- Has a sufficient level of English ( B1-C1 )

## Visa Requirements

Turkey is not yet in the EU so please bring along your passports! Some of you may need visa. You can get visa in airport. Please check the board before the passport control if you need visa or not. **It costs 20 USD ( 18 EUR ) if you buy from e-Visa and if you buy in the border, it costs 25 EUR.**

**Please check your passports that your arrival date is 6 months before your passport expiry date!**

Visa cost will be reimbursed %100 when it is presented.

For visa, you do not need apply for a visa and you can obtain in the border or from the website of the Turkish Foreign Ministry.

# Information About City

Antalya is the eighth-most populous city in Turkey and the capital of Antalya Province. Located on Anatolia's southwest coast bordered by the Taurus Mountains, Antalya is the largest Turkish city on the Mediterranean coast with over one million people in its metropolitan area.

The city that is now Antalya was first settled around 200 BC by the Attalid dynasty of Pergamon, which was soon subdued by the Romans. Roman rule saw Antalya thrive, including the construction of several new monuments, such as Hadrian's Gate, and the proliferation of neighboring cities. The city has changed hands several times, including to the Seljuk Sultanate in 1207 and an expanding Ottoman Empire in 1391. Ottoman rule brought relative peace and stability for the next five hundred years. The city was transferred to Italian suzerainty in the aftermath of World War I, but was recaptured by a newly independent Turkey in the War of Independence.

Antalya is Turkey's biggest international sea resort, located on the Turkish Riviera. Large-scale development and governmental funding has promoted tourism. A record 12.5 million tourists passed through the city in 2014.

The area is shielded from the northerly winds by the Taurus Mountains. Antalya has a hot-summer Mediterranean climate (Köppen: Csa) with hot and dry summers and mild and rainy winters. Around 300 days of the year are sunny, with nearly 3,000 hours of sunlight per year. The mean sea temperature ranges between 16 °C (61 °F) in winter and 27 °C (81 °F) in summer.[25] The highest record air temperature reached 45.4 °C (113.7 °F) on 1 July 2017 which normally averages as high as 34.4 °C (93.9 °F) and the lowest record dropped to -4.6 °C (23.7 °F) in February, when the low average is as low as 6.1 °C (43 °F).



# Travel Costs

We will reimburse travel cost during training course regarding to travel budget of the country.

**! Note:** Reimbursement of travel costs will only be done upon presentation of all (including return tickets) original tickets, receipt/invoices and boarding passes. Please print before all documents, which are related to travel expenses. This means that once home after the training, participants will be asked to send the originals of all return documents and boarding passes. Please remember to bring the original invoices – there will be no reimbursement without the original invoices and tickets with indicated Names of travellers, description of the journey, indication of cost and currency and date of travel.

Please do not lose your boarding passes; you will need them for reimbursement of travel cost.

**!!! Note:** Reimbursement will be done in EUR, regardless of the currency indicated on the ticket and receipt/invoice. Any tickets purchased in a local currency other than EUR, will then be converted and calculated according to the exchange rate of the March 2019 as stated in the official European Commission web-site at <http://ec.europa.eu/budget/inforeuro/index.cfm?Language=en>

You should arrange your own accommodation then. We are not responsible for the time you spend in Istanbul or Antalya out of project period.

# Travelling & Arrival To Venue

Antalya has only one airport, **IATA Code : AYT**, you might have direct flights from your country to Antalya, please check those flights in case, though there is more than 15 flights per day arriving from Istanbul to Antalya from **SAW( Sabiha Gökçen Airport )** or **IST ( İstanbul Airport )**.

While buying your tickets and you are thinking to have a connecting flight in Istanbul, please if you don't have more than 10 hours between the flights, don't consider changing airports in Istanbul, you might miss your flight related to traffic and transportation issues.

There is an another airport called **Gazipaşa Airport ( GZP )** in Antalya province, please as well don't buy your tickets to there, in that case we will not be able to provide you a transfer as it is 2,5 hours away from where we will implement the training.
